For this reason, the money was put into administration. According to Spanish law, existing prizes must be reviewed every two years. If the beneficiary is unable to attend, the profit will be reinvested for a further two years via an investment company. This is why we have been instructed by the Unclaimed Prizes Office to send you this email notifying you of this unclaimed money to date.
