## Call for papers

*The HELLENIC OPEN BUSINESS ADMINISTRATION Journal* invites contributions from a range of related fields of study centering on any theoretical or empirical issue on the journal's central concerns (business administration, public administration, economics, etc). These should be 7,000 words maximum, while shorter articles of between 2,000 and 4,000 words are welcome, and be written in a style which reflects the journal's readership in both academic institutions and practice.

The journal uses double-blind review, which means that both the reviewer and author identities are concealed from the reviewers, and vice versa, throughout the review process.

Manuscripts are submitted to the Editor by e-mail ([giannias@gmail.com](mailto:giannias@gmail.com)) with the understanding that they are original, unpublished works and are not being submitted elsewhere. Articles must be in a single attached Word file, which includes all tables, graphs etc.

# INSTRUCTIONS TO CONTRIBUTORS

All authors should be shown and author's details must be printed on a separate sheet; the author(s) should not be identified anywhere else in the article. An **e-mail** should be provided for all subsequent communication.

Articles should include an abstract of maximum 100 words, up to six keywords, and JEL classification.

Manuscripts are submitted to the Editor by e-mail (*giannias@gmail.com*) with the understanding that they are original, unpublished works and are not being submitted elsewhere. Articles must be in a single attached Word file, which includes all tables, graphs etc.

**The HELLENIC OPEN BUSINESS ADMINISTRATION Journal** is an Open Access journal that provides immediate, free availability on the public internet, permitting any users to read, download, copy, distribute, print, search or link to the full text of all published articles. Many authors in a variety of fields already realized the benefits that open access publishing can provide in terms of increasing the impact of their work.

Because the **The HELLENIC OPEN BUSINESS ADMINISTRATION Journal** will be published freely online to attract a wide audience), authors will have free electronic access to the full text (in PDF) of the article. Authors can freely download the PDF file from which they can print unlimited copies of their articles.

**Footnotes** (not endnotes) should be used only if absolutely necessary and must be identified in the text by consecutive numbers. If a footnote occurs after a word which is followed by punctuation, the number appears after the punctuation.

All **figures** and **tables** are titled and numbered (with arabic numerals) and are referred to as such in the text, e.g., "see Figure 1", "as shown in Table 7"). **Figures** and **tables** should be placed in the article (not all together in an Appendix).

**Headings** should not be numbered. Do not use capital letters for any of them. **Sections** should be **bold** and **subsections** *italics*.

In the text, **references** to other publications should be cited as follows (Name Year), e.g., (Smith 1998). If the name of the author has already been mentioned, the date alone may appear in parenthesis, e.g., "... as shown by Lave (1999)." For references authored by more than two contributors use first author's name and "et al". For multiple citations in the same year use a, b, c after year of publication. The reference list should be given at the end of the manuscript (following all tables, figures, and appendices) typed alphabetically according to the following style.

## *Book.*

Schumpeter, J.A., 1950, *Capitalism, Socialism, and Democracy*, 3<sup>rd</sup> ed., New York: Harper and Row.

## *Edited book.*

Buffie, E., 1990, Economic policy and foreign debt in Mexico. In: *Developing Country Debt and Economic Performance* (Sachs, J., ed), Chicago: University of Chicago Press, pp 184-233.

### *Journal.*

Baro, R., 1990, Government spending in a simple model of endogenous growth, *Journal of Political Economy* 98 (1): 103-125.

### *Unpublished reports, departmental working papers, etc.*

Gren, I.M., 1992, *Transition in the CEECs and the Former Soviet Union*, Beijer Discussion Paper Series No 14, The Beijer International Institute of Ecological Economics, Stockholm.

Once accepted for publication, the **final version of the manuscript** must be provided, in WORD format. The whole final version of the manuscript which is accepted for publication must be in one WORD file that includes all tables, figures, etc. The author(s) must ensure that the final version of the paper in this WORD file is complete, grammatically correct, and without spelling or typographical errors.

**Copyright:** Submission of a manuscript implies that the work described has not been published before (except in the form of an abstract or as part of a published lecture, or thesis) and that it is not under consideration for publication elsewhere; that, if and when the manuscript is accepted for publication, the authors agree to automatic transfer of the copyright to the publisher.

### **Fees and Charges:**

There is a **90 € (110 USD) submission fee**.

Upon final acceptance of an article, authors are required to pay a **190 € (220 USD) processing fee** for articles not exceeding 5000 words; this is increased by 50 € (60 USD) for each additional 1000 words

Publication of an article in ***The HELLENIC OPEN BUSINESS ADMINISTRATION Journal*** is not contingent upon the author's ability to pay the relevant fees and charges. Neither is acceptance to pay them a guarantee that the paper will be accepted for publication. Authors may still request (in advance) that the editorial office waives some of the processing fees under special circumstances; the latter always depends on availability of funding.

If the hardcopy of an issue is needed, costs for postage and handling apply; this amounts to **70 € (85 USD) for a single issue** and **110 € (130 USD) for a volume**. **Bulk orders** of single issues are also accepted.
